## Kraft FLVRS Club Official Rules

## NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: Kraft FLVRS Club (the "Promotion") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old (or nineteen (19) years of age or older for residents of Alabama and Nebraska) at the time of entry. Employees, officers, and representatives of Kraft Heinz Foods Company, Merkle Inc., as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Promotion consists of three (3) FLVRS phases (each a "Phase"), as outlined below.

Administrator's computer is the official time-keeping device for the Promotion.

**4. How to Enter:** During each Phase of the Promotion Period, the Sponsor will post on Twitter, Instagram and TikTok when each FLVR drop ("Drop") will occur. There will be two (2) Drops per FLVR Phase. Once the timing of the Drop is announced, visit <a href="www.KraftFLVRS.com">www.KraftFLVRS.com</a> and follow the links and instructions to complete and submit the registration form, including a valid email address. For the first Drop per FLVR, if you are the one of the first three hundred twenty-three (323) entrants to register, you are the potential winner of the applicable FLVR prize. For the second Drop per FLVR, if you are the one of the first three hundred twenty-two (322) entrants to register, you are the potential winner of the applicable FLVR prize.

<u>Limit</u>: Each entrant may enter one (1) time per Drop during the Promotion Period. Multiple entrants are not permitted to share the same email address. Any attempt by any entrant to obtain more than the stated number of plays by using multiple/different email addresses, identities, registrations and logins, or any other methods will void that entrant's plays and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected registrations, which will be disqualified. In the event of a dispute as to any registration or play, the authorized account holder of the email address used to register will be deemed to be the entrant or player. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider, Internet service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. Each potential winner may be required to show proof of being the authorized account holder.

**5. Winner Selection and Verification of Potential Winners:** Administrator is an independent judging organization whose decisions as to the administration and operation of the Promotion and the selection of the potential winners are final and binding in all matters related to the Promotion. If you are one (1) of the

first three hundred twenty-three (323) or three hundred twenty-two (322) (depending on the Drop) entrants to register for the Promotion, you are the potential winner of the applicable FLVR prize.

The potential winners will be notified by email. If a potential winner of any prize cannot be contacted, fails to provide any requested information within the required time period (if applicable), or the prize is returned as undeliverable, the potential winner forfeits the prize. Receiving a prize is contingent upon compliance with these Official Rules. In the event that a potential winner is disqualified for any reason, Sponsor will award the applicable prize to an alternate winner by selecting the next fastest entrant that entered the Promotion. Only three (3) alternate potential winners will be notified, after which the prize will remain unawarded. Prizes will be fulfilled approximately 8-10 weeks after the conclusion of the Promotion.

SIX HUNDRED FORTY-FIVE (645) RANCH FLVRS PRIZES (Three hundred twenty-three (323) awarded in the first Ranch FLVRS Drop and three hundred twenty-two (322) awarded in the second Ranch FLVRS Drop): Prize package includes a Ranch Hoodie, one box of Original KRAFT Macaroni & Cheese, and Ranch Flavor Sachet. All details of prize package are determined by Sponsor in its sole discretion. ARV: \$76.50.

SIX HUNDRED FORTY-FIVE (645) PIZZA FLVRS PRIZES (Three hundred twenty-three (323) awarded in the first Pizza FLVRS Drop and three hundred twenty-two (322) awarded in the second Pizza FLVRS Drop): Prize package includes a Pizza Windbreaker, one box of Original KRAFT Macaroni & Cheese, and a Pizza Flavor Sachet. All details of prize package are determined by Sponsor in its sole discretion. ARV: \$49.50.

The odds of winning a prize depend on the time you register for the Promotion in relation to the rate at which others register for the Promotion. No cash or other substitution, assignment or transfer of any prizes permitted, except by Sponsor, who reserves the right to substitute a prize or prize component with cash or another prize of comparable or greater value. General Conditions: Sponsor reserves the right to cancel or modify the Promotion if fraud, technical failures, human error or any other factor impairs the integrity of the Promotion, as determined by Sponsor in its sole discretion. In such event, Sponsor reserves the right to award the prizes at random from among the eligible entries received up to the time of the impairment. Sponsor reserves the right, in its sole discretion, to disqualify any individual it finds to be tampering with the entry process or the operation of the Promotion, or to be acting in violation of the Official Rules of this or any other promotion, or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately damage any website or undermine the legitimate operation of the Promotion is a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
- **9. Release:** By receipt of any prize, winner agrees to release and hold harmless Sponsor, Administrator, and any promotional partners, each of their parent, subsidiary, affiliate, and related companies, and each of its and their respective officers, directors, employees, and agents (collectively the "Released Parties") from and against any losses, damages, rights, claim, or cause of action of any kind arising, in whole or in

part, directly or indirectly, out of participation in the Promotion or resulting directly or indirectly, from acceptance, possession, use, or misuse of any prize awarded in connection with the Promotion, including without limitation personal injury, death, and/or property damage, as well as claims based on publicity rights, defamation, and/or invasion of privacy.

Limitations of Liability: The Released Parties are not responsible for: (1) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Promotion; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines, or network hardware, or software; (3) unauthorized human intervention in any part of the entry process or the Promotion; (4) technical or human error which may occur in the administration of the Promotion or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Promotion, or receipt, or use of any prize or while traveling to or from any prize-related activity. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Promotion, if it is possible. Disputes: Entrant agrees that: (i) any and all disputes, claims, and causes of action arising out of or connected with this Promotion or any prizes awarded shall be resolved individually, without resort to any form of class action, and exclusively by the United States District Court for the Eastern District of Michigan (Southern Division) or the appropriate Michigan State Court located in Oakland County, Michigan; (ii) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Promotion but in no event attorneys' fees; and (iii) under no circumstances will entrant be permitted to obtain awards for and entrant hereby waives all rights to claim punitive, incidental, and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
